August 1st – 8th, 2016

August 2nd

- The Weyburn PS was dispatched to a report of a medical emergency at the Don Mitchell paddling pool. A 6 year old child was the victim of a near drowning. Due to the quick actions of some other patrons the boy was retrieved from the water and provided with what may have been life saving first aid. The child was transported to the hospital for assessment.

Although the paddling pool has a staff member on duty there is no lifeguard. Parents are urged to be extra diligent when at the pool and to never leave young children unattended when in the water.

- The Weyburn PS responded to a report of a 2 vehicle collision on 4th Avenue South. The investigation revealed that one of the vehicles which was thought to have been in Park rolled down the incline colliding with another vehicle. There were no injuries.

- The Weyburn PS is investigating a report of break-ins and mischief to the buildings at Tom Laing Park. A number of items from the concession were taken including alcohol and Weyburn Beaver's merchandise. The matter is actively under investigation

August 3rd

- Just after midnight the Weyburn PS were dispatched to a residence regarding a 30 year old male who was threatening self-harm. The person was taken into custody without incident for being intoxicated in public and held in cells until sober.

August 5th

- The Weyburn PS received a call regarding a homeowner who had threatened a door-to-door salesperson. Although the victim did not wish anything formal to be done the homeowner was spoken to and advised that his conduct did constitute a criminal offence and that he could be charged. While emotions can run high in these door-to-door events we urge people to remember that they can easily become the suspect in a criminal investigation if threats are uttered or a salesperson is assaulted.

August 6th

- Just after midnight the Weyburn PS were dispatched to the business area on the east side of the City regarding a suspicious male. A 52 year old male was located and was arrested for being intoxicated in public. He was held in cells until sober.

- At about 4am the Weyburn PS was dispatched to a report of a domestic dispute in progress. Upon arrival the police learned the victim had fled the scene. A 39 year old male was subsequently charged with assaulting the 37 year old victim as well as being charged with Breaching a Court order. The following day the accused was found to be Breaching the current release document and was arrested. He is being held pending a Court appearance August 9th.

August 7th

- At about 8pm the Weyburn PS was dispatched to a report of a domestic dispute in progress. Upon attending they found that a 26 year old female and a 43 year old male were arguing over family issues. The male agreed to remove himself from the residence until things cooled down. There was no further need for police involvement.
