

Weyburn Police Service
Media Release October 25, 2015 to November 1, 2015

On October 25th, Weyburn Police Service received a complaint regarding a family relations issue, where during an arranged visitation between a grandparent and grandkids the parent became angry and some yelling occurred. Police spoke with those involved and no charges resulted.

On October 27th, members of the Weyburn Police Service attended to a Downtown business after a 30 year old male had entered the store and started to threaten the store owner. The male left the store prior to police arrival. Police later located the male who was subsequently arrested and charged with threatening, and released to appear in court at a later date.

On October 27th, the Weyburn Police Service received a complaint of a theft from a local business. The complainant advised police it was an internal theft. The resulting investigation ended with a 17 year old male being arrested and charged with theft under \$5000. He was released for court at a later date.

On October 28th, members of the Weyburn Police were dispatched to a suspicious person complaint at a local residence. The subsequent investigation determined an 18 year old female was breaching her prior release conditions. She was located in the vicinity of the residence and arrested and charged. She was released to appear in court at a later date.

On October 28th, members of the Weyburn Police Service were dispatched to a two vehicle motor vehicle accident on a downtown parking lot. The investigation determined the one driver; a 70 year old female had accidentally put the vehicle in drive and struck another vehicle.

On October 30th, Weyburn Police Service received a complaint of a theft of an ipod, after the complainant learned an old roommate had sold the ipod to another individual. Police have charged a 26 year old male with theft and possession.

On October 30th, Weyburn Police Service received a complaint of a fraud and threatening. After the complainant advised police they were selling tires on Kijji and they had been contacted by a male who was interested in the tires. The male had sent a cheque in an amount larger than the purchase price and requested the complainant send the excess funds back. The complainant realized this was probably a scam and contacted police. The investigation into this matter continues.

On October 31st, Weyburn Police Service received a call of a possible impaired driver who was leaving a local hotel. Police later located the suspect vehicle and arrested a 28 year old male. He was subsequently charged with impaired drive and driving while over .08. He was released when sober and will appear in court at a later date.

Police responded to a number of complaints on Halloween evening though the majority of the calls were minor in nature such as suspicious persons, or minor mischief complaints.

On November 1st, a member of the Weyburn Police Service observed a vehicle driving in a manner that would indicate a possible impaired driver. The vehicle was stopped and the driver, a 34 year old male, showed signs of impairment. The driver was arrested and subsequently charged with impaired drive and drive over.08. He was later released from custody to appear in court on a later date.
