Media Release for the week of September 18th – September 24th 2016

September 18th - Police members responded to a report of a domestic disturbance at a residence in the east side of the City. Police arrived a short time later and found that one of the parties had already left the residence. Police left and were called back to the residence when the individual returned. Police re-attended and an 18 year old male was arrested for breach of the peace and was later released when sober.

September 19th - Police attended to an attempt Break and Enter to a Business in the east side of Weyburn after the owner noticed damage to an exterior door. Entrance was not gained and nothing was reported stolen. The incident remains under investigation.

September 19th – Police were dispatched to a single vehicle accident in the 200 Block of 8th Street NE. On arrival police found the vehicle had hit a tree. The 49 year old female driver was taken to hospital for treatment. Alcohol is believed to have been a factor in the accident and the investigation into the accident continues.

September 19th - Police received a complaint of a theft of a trailer from a local business. The trailer is described as a Precision Trailer, black in color , with Saskatchewan license 191KHY. It is believed the trailer was stolen sometime around September 15th. The incident remains under investigation.

September 19th – Police received a report of a two vehicle accident at the intersection of 7th Street NE and Railway Avenue, after one vehicle rear ended a vehicle that had stopped at the intersection. The driver who was stopped at the intersection reported minor injuries as a result of the collision.

September 21 - Police received a complaint of a fraud after the victim answered an ad on Kijiji where a company would pay if ads were put on their vehicle. The complainant received a cheque which was to be cashed and the victim was to keep their share and return the rest of the money to the company. The victim felt this was a fraud and reported it to police immediately. No financial loss was incurred by the victim. The fraud remains under investigation.

September 22nd - Police received a complaint of a potential fraud after an individual attended a local business and attempted to solicit funds for Special Olympics. The solicitation of funds, by this individual, was not an authorized fund raising event by Special Olympics. Police have a person of interest identified and the investigation is ongoing.

September 23rd - Police attended to a Break and Enter of a business in the 600 Block of Government Road. Entrance had been gained through a window, and once inside the suspect or suspects ransacked the offices, stealing cash. The incident remains under investigation.

September 23rd – Police attended to a Break and Enter of a business in the 400 Block of Prairie Avenue. Entrance was gained through a window, and nothing was reported stolen. The incident remains under investigation.

September 23rd – Police attended to a domestic dispute at a residence in the east area of Weyburn. The subsequent investigation identified allegations of an assault that may have occurred during the course of the argument. The situation was mediated, though the investigation into the alleged assault is ongoing.

September 23rd - While on patrol police observed what appeared to be a number of individuals causing a disturbance in the parking lot of a downtown bar. Police responded and during the course of the investigation a 43 year old male was arrested and charged for drunk in public. This individual was lodged in cells and later released when sober. During the course of this investigation another individual was identified as being involved in an assault. The 36 year old male was arrested and charged with assault. He was also lodged in cells and later released with a court date in October.

September 24th – Police received a report of a fraudulent use of a credit card, after the victim was advised of unusual activity on his credit card. The victim found that their vehicle had been broken into and a wallet stolen and credit card was being used at a local business. The incident remains under investigation.

September 24th – While on patrol police located a very intoxicated individual walking on the street in the down town area, the 31 year old male was arrested for drunk in public and lodged in cells. He was later released when sober.

September 24th - While on patrol police located a very intoxicated individual on the street in the down town area, the 36 year old male was arrested for drunk in public and lodged in cells. He was charged with being drunk in public and later released when sober.
