

**Weyburn Police Service**  
**Media Release November 15, 2015 to November 22, 2015**

Nov 15 - Police while on routine patrol came across a vehicle parked on the front grass at the High School, Male subject was in the driver's seat of the running vehicle and an odor of alcohol was detected. Police administered a breath test and male was given a 72hr driving suspension.

Nov 16 - Police responded to a local Hotel for a disturbance call of a male and female yelling. Police spoke to a male and female in the room and the male was found to be on conditions to not leave Whitby, ON. Male was arrested for Breach and held for court in Weyburn on Nov 18. There were no other charges.

Nov 17 - Police responded to an accident at the corner 1<sup>st</sup> ave and Govt, rd, vehicle travelling NB on Govt rd failed to stop at the red light and struck a vehicle travelling W on 1<sup>st</sup> ave. Driver was charged with fail to stop at red light there were no injuries and one vehicle had to be towed from scene.

Nov 17 - Police responded to an MVA at the corner of Sims ave and Govt Rd, one vehicle had to be towed and there were minor injuries to driver and passenger of vehicle that was towed. Other driver charged with making an illegal left turn.

Nov 18 - Police were dispatched to the intersection of Govt Rd and Souris ave to direct traffic as the traffic lights on the East side of Souris Ave had blown over due to the high winds. The Cp rail crossing arm at Govt Rd had blown down and broke at the same time. There was no damage to any vehicles with either of these incidents.

Nov 19 - Police responded to an accident 2<sup>nd</sup> and Co-Op grocery store, vehicle came out of the parking lot striking a vehicle that was travelling on 2<sup>nd</sup> st. Vehicle had to be towed and driver was charged with fail to yield when entering roadway. There were no injuries.

Nov 19 - Local business called Police reporting a shoplifter, suspect was observed on camera stealing product, shortly after another business reported the same suspect stealing approx \$400.00 worth of product from their business. Suspect of both thefts is a younger adult female and has not been identified by Police as of yet, investigation is ongoing.

Nov 20 - Police responded to Hwy 39 and Govt rd for a MVA, Both vehicles were travelling south on Govt rd when vehicle 1 stopped at the intersection vehicle 2 struck vehicle 1 from the rear. Driver of vehicle 1 was transported to Hospital and was released with minor injuries driver of vehicle 2 was charged with Driving without due care and attention.

Nov 20 - Police received a complaint of a suspicious male on hwy 39 on the east side of the City, Police found a male subject that appeared confused and intoxicated, subject was found to be on conditions for no alcohol and was arrested for breach. Once in Police custody it was found the accused gave Police a false name, now positively identified he was found to have warrants out of Regina, Police charged the adult male with Obstruction and he was released the following day in front of the Justice of the Peace.

Nov 21 - Police responded to a local downtown business for a report of a stolen vehicle, vehicle was left running in front of the business when the owner came out the vehicle was gone. Police later recovered the vehicle on the North end of the City. Investigation is ongoing

Nov 21 - Police responded to an MVA at the intersection of 16<sup>th</sup> st and Warren Ave, one vehicle had to be towed and one person was charged with Drive Undue Care and attention. They were no injuries
