November 23rd

At about 5:10 pm the Weyburn PS responded to a 2 vehicle collision on King Street. As a result of the investigation a 16 year old male was charged with Leaving a Stop Sign before Safe to do so. There were no injuries.

November 25th

At about 3:55 pm the Weyburn PS responded to a report of a vehicle collision. As the result of the investigation a 38 year old male was charged with leaving a stop sign before safe to do so.

The Weyburn PS received a report involving a child safety / custody matter. The police attended to the residence and assessed the situation. No immediate child safety issues were identified. The matter was referred to Social Services.

The Weyburn PS became aware of an individual who may considering harming himself. The 42 year old male was located. It was learned that there was an arrest Warrant outstanding for the person. He was taken into custody on the warrant.

November 26th

At about 10:30am the Weyburn PS responded to a 2 vehicle collision at the Hwy # 39 and 3rd Street intersection. There were no injuries. The vehicles were not driveable. As the result of the investigation an 18 year old male was charged with Driving Without Due Care & Attention.

November 27th

As the result of an ongoing incident the Weyburn PS responded to a local business which had been the victim of others driving erratically on their parking lot. Through the investigation the suspect vehicle was identified along with the driver responsible. The erratic driving action had been going on for some time. A 16 year old female has been issued traffic tickets for; driving without due care & attention, driving in a manner likely to startle other users of the road and with driving left of center.

At about 11:45 am the Weyburn PS responded to a domestic disturbance call involving a 41 year old male and a 33 year old female. As a result of police intervention one of the people agreed to leave the residence for the day to allow tempers to cool. There was no further need for police involvement.

At about 6:30 pm the Weyburn PS received a report of a 59 year old male who was refusing to pay his bill at a local business. As the result of police intervention the bill was paid and the person was prohibited from attending the business for a 6 month period.

The Weyburn PS received a report of a vehicle that had been stolen. Through the services of the onboard navigation system the vehicle was located in the rural area. The RCMP assisted in its recovery. The matter is still under investigation.

November 28th

At about 3:25 am, while on patrol the Weyburn PS came across a heavily intoxicated 21 year old male. The male was arrested for being drunk in public and held in police custody until sober.

November 29th

At about 12:30 am the Weyburn PS conducted a traffic stop to check for documentation and driver sobriety. As the result of the check a 30 year old female was arrested and is facing charges of Driving Over .08.

On August 30th, 2015 the Weyburn PS responded to what was determined to be a home invasion robbery. 3 male; a 32 year old Weyburn resident, 1 28 year old Weyburn resident and a 25 year old Edmonton resident have now been charged with various offences surrounding that incident.
