

**Weyburn Police Service**  
**Media Release March 6, 2016 to March 13, 2016**

March 13<sup>th</sup>

Weyburn Police Service received a complaint of an assault after an altercation occurred between two individuals at a downtown bar. The altercation occurred as both individuals were trying to get into a cab for a ride home. The investigation is ongoing

Members of the Weyburn Police Service attended to a local resident after receiving complaints of a domestic dispute. Members attended and assisted one of the parties to leave the residence. No charges were laid.

March 14<sup>th</sup>

Weyburn Police Service members responded to a report of theft from Walmart. Employees advised a male ran out of the emergency exit with merchandise from the store. The male got in a vehicle with 2 other males and fled the area. The employees provided officers with a plate number which came back to a truck stolen out of Regina. The investigation is ongoing.

A local resident reported a mischief, after his parked vehicle had been vandalized. The exterior mirror had been broken off. No witnesses or suspects have been identified at this time.

A local property owner reported a theft from his rental property. A tenant reportedly took the 50" TV off of the wall when he vacated the property. The investigation is ongoing

March 15<sup>th</sup>

The Weyburn Police Service received a mischief complaint from an individual who reported that the vehicle was damaged while parked in the Walmart lot. No witnesses or suspects have been identified at this time.

March 16<sup>th</sup>

Weyburn Police Service members attended a local residence to check on the welfare of a female who was threatening to harm herself. The female indicated that she was very down but that she would be OK and refused any medical attention. Officers stayed with the female until a friend arrived to stay with her.

March 17<sup>th</sup>

The Weyburn Police Service received a report from a young female who indicated that she was sexually assaulted while on a recent holiday out of the country. The incident is under investigation and will eventually be forwarded to the country of jurisdiction for further investigation.

Police were called to assist EMS personnel after they had received reports of a male who had been knocked out. The male was located at a local residence and had apparently passed out from the consumption of an excess of alcohol as there was no evidence of an assault. The male was transported by EMS to hospital for treatment.

### March 18<sup>th</sup>

A local resident reported a break and enter after someone broke the front door handle and a basement window of the residence. The house was searched but nothing was noted to be missing. The matter is being investigated.

A local resident reported a suspicious van with Manitoba plates and 3 males wearing hoods driving around their neighborhood. Police later located the vehicle and spoke to the occupants where it was determined they were delivering the new phone books.

Officers were called to a local residence in response to a domestic dispute, after a couple got into a physical fight. Both parties were arrested and charged with assault and later released. Both parties will be making a court appearance later in April.

### March 19<sup>th</sup>

Officers received several calls of a marketing company going door-to-door. Reports indicated the salesmen were fairly pushy and aggressive in nature. Officers located and spoke to the individuals and their supervisor. They were advised not to conduct any further business in the area until they acquired a business license from the City of Weyburn.

As a note of caution, it is advisable if a door to door salesman shows up at your door to ask them for their City Business license, as well as their company ID. Should there be concerns please contact the Weyburn Police Service.

### March 20<sup>th</sup>

Weyburn Police Service members responded to a semi & trailer unit that was flipped over on its side and completely blocking highway 39 near the Nickel Lake turnoff. The semi was very hard to see due to the dark colors. Police, EMS, and Fire personnel attended. The scene over to the RCMP upon their arrival, and the male driver was transported to WGH where he was treated and released.

Members of the Weyburn Police Service responded to a disturbance after reports of two individuals yelling. It was determined the two individuals who are in a domestic relationship had gotten into an argument and were yelling at each other. Police spoke with both involved and one party left to allow the situation to cool down. No charges were laid.

Officers responded to a 911 call reporting a vehicle on fire in the driveway of a local residence. Members arrived to find the front of a vehicle engulfed in flames and a resident attempting to put it out. Officers had the resident and the surrounding vehicles moved to safety. Fire personnel arrived and extinguished the flames. Two vehicles and the front of the garage attached to the residence suffered damage.
