Weyburn Police Service Media Release March 6, 2016 to March 13, 2016

March 7th

The Weyburn PS are investigating the report of a theft of property from a vehicle parked in the 700 Block of Brimacombe Drive.

The Weyburn PS were contacted regarding a family dispute involving a 66 year old male and a 28 year old male. The matter was resolved at this time.

March 8th

At about 4:25 am the Weyburn PS received a 911 call from a male in distress. Upon attending to the address it was learned that a 30 year old male and a 23 year old female had been in an altercation. The male voluntarily left the residence for the evening. There was no further police involvement.

The Weyburn PS are investigating a complaint of bank fraud. In this case it appears that an unknown person remotely accessed a local residents account depositing 2 fraudulent cheques. The money was then withdrawn from the account.

Given the nature of this incident and the fact that the suspect was able to remotely access a bank account, we ask that people be diligent in checking their bank records to make sure that no unauthorized transactions appear.

At about 8:45 pm the Weyburn PS received a call to a residence on Elizabeth Street regarding a suspicious male who had been found in a garage. The male fled the scene in a grey car with partial Sask. licence 298J??. Anyone having any information regarding this vehicle, or who may have seen a suspicious male about that time in the area is asked to contact the Weyburn Police or call Crime Stoppers.

While attending a call on Maple Drive a vehicle being driven by a 47 year old male was observed to be driving too fast around the curve and struck a parked vehicle.

March 10th

At about 7:35 pm a 2011 Silver Dodge Ram 2500 was stolen from the parking lot behind Pharmasave and was last seen travelling East on Railway Avenue. The victim observed 2 younger people get into the vehicle just as he was exiting the store. Anyone having information on this incident is asked to contact the Weyburn PS, or to call Crime Stoppers.

At about 9:20 pm the Weyburn PS responded to a call regarding a motor vehicle collision. Upon investigating a 50 year old male has been charged with Driving with Undue Care and Attention.

At about 9:35 pm the Weyburn PS responded to a report of a domestic disturbance. Upon attending the residence the found a 22 year old male and a 25 year old female had been arguing about the male being able to leave the residence. The matter was mediated with the male leaving the residence.

March 12th

At about 2:30 am Members of the Weyburn PS observed a vehicle being driven in a suspicious manner attempting to avoid police. The vehicle was eventually located on Highway # 39 and stopped. The 19 year old male driver was arrested at the scene and has been charged with Impaired Driving.

At about 10:30 pm the Weyburn PS were called to a report of a male person violating previous release conditions in regards to a domestic matter. While actively looking for the male he attended the Weyburn PS office. As the result of the investigation the 45 year old male was arrested and charged with Breaching his Undertaking conditions to have no contact with the other person.

The Weyburn PS received a complaint of a 25 year old male violating his Probation conditions be contacting the 18 year old victim. As a result the male was arrested and charged with Breaching his Probation Order and will be making a Court appearance.

March 13th

The Weyburn PS are investigating a report of a 36 year old male being assaulted by a 49 year old female.

At about 7 am the Weyburn PS received a call from a distraught female asking for assistance to leave a residence. Upon arrival the 29 year old female left with police assistance. The matter is still under investigation.
