# PRESS RELEASE FOR JANUARY 18, 2017 to JANUARY 30, 2017

## January 18

The Weyburn PS is investigating a theft of fuel from a business vehicle parked in the central industrial area of the City.

The Weyburn PS has received a few reports over the past week of scams and frauds. In one case it was a computer virus repair scam. In the other it was a Revenue Canada scam. We continually urge people to be diligent in committing to anything on-line or to giving out any personal information to anyone whose identity is not certain.

At about 5:55 pm the Weyburn PS responded to a report of a 2-vehicle collision at 1st Street NE and Coteau Avenue. Through the investigation it was determined that a vehicle travelling North on 1st Street initially stopped at the stop sign, but began to travel again prior to it being safe to do so. This resulted in the vehicle colliding with a vehicle traveling West on Coteau Avenue. The 74 year old female driver of the northbound vehicle was issued a ticket for leaving a Stop Sign before safe to do so. She was also transported to the local hospital with what appeared to be minor medical issues.

At about 8pm the Weyburn PS was called to mediate a dispute between an estranged couple. The matter was mediated.

## January 19

The Weyburn PS received a report of harassing communications taking place between a 33 year old female and a 20 year old female. The matter has hopefully been resolved.

### January 20

The Weyburn PS received a report regarding an assault between a 20 year old male suspect and an 18 year old female victim. The matter is still under investigation.

The Weyburn PS is investigating mischief done to a number of vehicles parked together in the 400 Block of 13th Street NE.

At about 5:10 pm the Weyburn PS responded to a 2-vehicle collision on Government Road at Railway Avenue. The investigation has revealed that the 50 year old female driver of one of the vehicles suffered some form of medical distress which resulted in the vehicle she was driving rear-ending a vehicle stopped for a passing train. The driver was taken to the local hospital for assessment.

We urge residents to be wary of any such call, and if you have any doubt about the validity of the call hang up and return the call to a CRA number you have obtained from the telephone book or the official CRA website.

At about 3:40 pm the Weyburn PS was dispatched to an apartment complex regarding a dispute between neighbours and an allegation of assault. The investigation revealed that there was a misunderstanding between a 72 year old female and a 75 year old female regarding money owed to the other. # January 26

At about 10:20 pm the Weyburn PS was dispatched to a report of an altercation at a residence in the 300 Block of Mergens Street. Upon arrival it was determined that this was a long-standing family dispute between an estranged couple. The 64 year old male had already left the location when police arrived. There was no further need for police intervention. Alcohol was a factor.

#### January 28

The Weyburn PS was approached by a witness to a Hit & Run vehicle collision having just occurred in the City Centre Mall parking lot. The suspect is believed to be an 87 year old female driver. The matter is still under investigation.

At about 4:35 am the Weyburn PS was dispatched to the 100 Block of 9th Street to a report of a domestic dispute with a physical altercation. Just as police arrived a 31 year old male fled the scene on foot and was pursued by police eventually being arrested without incident. He was held in custody for being intoxicated and released later in the morning. After speaking to the other people involved it was

determined that no charges would be laid. Alcohol was a contributing factor.
