**April 24**

The Weyburn PS is investigating a report of a commercial B & E in the 400 Block of 10<sup>th</sup> Avenue SE. The matter is still under active Investigation. If you have any information on this please contact Crime Stoppers at 1-800-222-8477.

**April 26**

At about 5:35 pm a complaint was received about a male acting oddly. The 32 year old male was located and subsequently arrested for being Intoxicated in Public and was held in cells until sober.

At about 11:05 pm the Weyburn PS responded to a domestic disturbance in the 300 Block of 4<sup>th</sup> Street. As a result of this call a 40 year old male was taken into custody without incident and is facing a charge of Breaching a Probation Order.

**April 27**

At about 10:20 am the Weyburn PS was notified by a local business owner regarding an internal theft problem. As the result of the investigation a 57 year old male has been charged with Theft Under \$5000.

At about 3:00pm while conducting a traffic enforcement check the 28 year old driver of a vehicle was being stopped for a speeding violation. The driver, rather than stop, fled from the Police and then ran into a private residence with the Police in pursuit. The male has been charged with Speeding and also with Failing to Stop for the Police.

At about 3:25 pm the Weyburn PS received a request from a local health care facility to locate and return a patient who had left without permission. The person was located and returned without incident.

**April 28**

At about 11:30 pm the Weyburn PS responded to a domestic disturbance between a 28 year old male and a 30 year old female. Police assisted the male to leave the residence with his infant child.

At about 11:56 pm the Weyburn PS received a call about a disturbance on the street in the area of Bison Avenue and 6<sup>th</sup> Street, between 2 or more people. Before police were able to respond a vehicle came and removed at least one of the people.

At about 10:30 pm the Weyburn PS received a complaint of Mischief having been done to a vehicle parked at a restaurant. The matter is still under investigation.

**April 30**

At about 5 am the Weyburn PS received a call regarding a 22 year old male person who was contacting the complainant when under an Order not to do so.. The matter is still under investigation and charges are pending.

At about 3 pm the Weyburn PS received a report of a domestic assault to an 11 year old child. The matter is still under investigation and the Police are working in conjunction with the Ministry of Social Services.

At about 10:30 pm the Weyburn PS received a complaint regarding a 19 year old male who was threatening self-harm. The person was located and was voluntarily taken to the Weyburn General Hospital for assessment.

**May 1**

Police responded to a medical center for a report of an assault on a medical provider. Police arrested and charged a 22 year old female with assault. The accused was later released from custody for court in Weyburn at a later date.

Police attended a medical center to assist staff with an unruly patient. Police were able to assist with calming the individual. No charges were laid in this incident.

**May 2**

Police responded to a residence for a report of a domestic assault in progress. Upon arrival it was found both parties were intoxicated and no assault occurred. The situation was mediated and parties agreed to leave each other alone. No charges were laid.

Police received a report of a fraud over \$5000.00 dollars. The victim received a message believing it was from his bank and gave sufficient information to the caller that they were able to access the bank account and take funds. Police want to remind people to be very cautious and to not respond by text or email or give out by phone any personal information about their bank accounts.

**May 3**

Police responded to a local school for a report of mischief to a vehicle, Investigation is ongoing. Police have had several reports of mischief to vehicles over the last few weeks. Though it might appear funny to put things on others vehicles, the act may cause damage or interfere with the lawful enjoyment of the vehicle which constitutes the criminal act of mischief, and may result in criminal charges being laid against the offender.

Police performed a High visibility check stop, in an effort to reduce the incidents of impaired driving, on Government Rd with over 220 vehicles checked. Police are happy to report there were no infractions noted during this evenings check stop.

**May 4**

Police responded to a local business for a report of a disgruntled customer, upon arrival all parties involved were calmed down and the investigation did not result in charges being laid.

**May 5**

Police responded to a domestic situation at a house in Weyburn, upon arrival it was found that this disturbance was from one party moving out and wanting their belongings. Police assisted c in keeping the peace.

**May 7**

Police conducted a high visibility traffic stop in Weyburn on Hwy 39, in an effort to reduce Impaired Drivers. Police checked 17 vehicles and found the driver of one vehicle to be impaired by alcohol and he was arrested.

The accused blew nearly 3 times over the legal limit was charged with impaired drive and over .08. The driver was also charged with speeding, open liquor in a vehicle and driving without appropriate license. The 21 year old male was released from custody when sober and will be appearing in court at a later date. Police responded to a report of a break and enter to City of Weyburn property where several items were reported stolen. The investigation is ongoing.

Police also had numerous complaints of Hit and Runs, which is a weekly occurrence. Police want to remind motorists that when a person hits another vehicle it is the law to either stay on scene to report to Police or make sure they let the other property owner know what had occurred and exchange information.

**May 8**

The Weyburn PS responded to a report of a commercial B & E in the 10 Block of 16<sup>th</sup> Street NE where a number of smaller tools and equipment was taken.

At about noon the Weyburn PS received a report from a 37 year old male that he had been assaulted by a 32 year old male. The matter is still under investigation and charges are pending. Alcohol was a contributing factor.

At about 8:25 pm the Weyburn PS responded to a suspected domestic dispute between 2-41 year olds. The matter was mediated without further need for police involvement.

**May 9**

The Weyburn PS received a number of complaints regarding a vehicle being driven erratically. As a result of the investigation a 17 year old male was located and has been charged with Driving Without Consideration for Others using the Road.

At about 1pm the Weyburn PS received a report of a possible domestic disturbance in the 800 Block of 5<sup>th</sup> Street NE. Upon attending they found a 28 year old male and a 23 year old female having a heated disagreement. The matter was mediated at the scene.

At about 4:15pm Members of the Weyburn PS received a complaint regarding a 55 year old male apparently passed out. The male was located and arrested for being Intoxicated in Public as well as for a criminal charge of Breaching a previous Court Order. He will be making a subsequent Court appearance.

At about 7:25 pm a number of emergency services responded to a 2-vehicle collision at King Street and 1<sup>st</sup> Avenue N. Although the incident looked severe there were no injuries.

The Weyburn PS received a report of Mischief done to a building on the Weyburn Fair Grounds. Someone had spray painted various lettering and symbols on the building.

**May 11**

The Weyburn PS was advised that there was what appeared to be a telephone scam involving Reader's Digest going around. As always, we urge our residents to be absolutely certain you are conducting legitimate business before releasing any personal or financial information.

The Weyburn PS responded to a report of Mischief to a garage in the 10 Block of 2<sup>nd</sup> Avenue SE where the windows appear to have been shot out with a pellet gun.

The Weyburn PS received a report regarding the actions of a 37 year old male in collecting a debt against a 22 year old male. It appears that the accused threw a bicycle at the victim's vehicle causing damage to the vehicle. The 37 year old has been charged with Mischief.

**May 12**

At about 3am the Weyburn PS became aware of a 16 year old male who was breaching a court-imposed curfew condition. The 16 year old male has been charged and will be making a Court appearance in the future.

The Weyburn PS was advised by one of the Financial Institutions that a counterfeit \$100 bill had been received by them. The photo image was blurry and discolored and the bill was peeling. The matter is still under investigation.

The Weyburn PS received a report that a number of vehicles in the 400 Block of Government Road may have had their tires slashed over the night.

The Weyburn PS is investigating a report of mischief caused to personal property relating to a domestic split-up.

**May 16**

The Weyburn PS was called to a local health care facility regarding damage that had been done by a patient. The Patient has been charged with committing Mischief and will be making a Court appearance.

At about 3:05 pm the Weyburn PS received a report of a possibly intoxicated driver. The 70year old driver was located and a 72 hour licence suspension was issued.

At about 6:10 pm the Weyburn PS received a call to a local bar to deal with an unruly patron. A 32 year old male was escorted from the property and is prohibited from attending the bar.

At about 6:50 pm the Weyburn PS received numerous complaints from area residents regarding a vehicle being driven very erratically and doing mischief to newly planted grass. The vehicle was located and as a result of the investigation the following have been charged;

- o 22 Year old Female driver being charged with; Impaired Driving, Drive Over .08, Drive While Disqualified (this person had only recently been convicted of another Over .08 offence), and Obstruction of a Peace Officer
  - o 29 year old Female being charged with: Obstruction of a Peace Officer
- The vehicle was impounded and both accused will be making a Court appearance in the future.

**May 18**

The Weyburn PS is investigating the attempted theft of a number of tools from a business in the 100 Block of Government Road. The suspect is described as: male, mid 30's age, slender build, wearing a blue zip-up jacket, sunglasses and jeans. The suspect vehicle he made a get-away in is believed to be a newer model 4 door silver sedan with tint in the rear windows

**May 19**

At about 2:15am the Weyburn PS received a call about suspicious pedestrians in the 300 Block of 4<sup>th</sup> Street. A group of youths were located but it is unknown at this time if any of them were involved. As a result of the police interaction with this group a 16 year old male was Arrested for being Intoxicated in Public and lodged in cells until sober.

The Weyburn PS received numerous calls this week regarding possible scam telephone calls relating to the STARS Lottery. While we believe these to be scam calls, please before giving out any personal or financial information verify with someone the legitimacy of the call.

The Weyburn PS received a report of a vehicle having been damaged over the weekend. It appears that perhaps a window was shot out with a pellet gun.

At about 1:10am The Weyburn PS received a call regarding a suspicious vehicle parked in the 400 Block of Edward Street. Upon attending they located the vehicle and a 58 year old male driver. The driver was taken into custody for Impaired Care & Control of a vehicle and is now facing charges and will be appearing in Court.

At about 10:35 pm the Weyburn PS received a report for a liquor sales outlet that a person had just attempted to use false identification. The suspect was located. A 16 year old male has been charged under the Alcohol, Gaming & Regulation Act.

At about 2:50 am the Weyburn PS conducted a traffic stop on a vehicle being driven by a 17 year old male. Although the driver was not driving under the influence of alcohol it was believed he was driving under the influence of drugs. A Standard Field Sobriety Test was conducted and as a result a 60 day Driving Suspension and 3 day vehicle impoundment was rendered against him.

The Weyburn PS received a report of a vehicle having had the window smashed out and some property taken. The vehicle was parked over the weekend in the 600 Block of Bison Avenue
