Media Release for July 10 – July 23, 2017

July 10

Police responded to a domestic dispute in the East end of the City. Neighbors reported hearing yelling and arguing. An adult female and an adult male were found to be having a verbal altercation. Police assisted in calming the situation and no charges were laid.

July 13

Police responded to a complaint of mischief to a vehicle in the central part of the City. Unknown persons had smashed the glass in a vehicle that was parked. The matter is under investigation.

Police responded to a hit and run in the North Central area of the city. An unknown vehicle had struck a parked vehicle causing damage. The unknown vehicle fled the scene without reporting the damage to the owner or the Police. The matter is under investigation.

Police responded to a complaint of mischief to a vehicle parked in the North end of the City. Unknown persons caused damage to the window of a parked vehicle. The matter is under investigation.

Police responded to a report of an intoxicated adult male that had fallen down on the sidewalk in the North Central area of the City. Police attended and EMS attended. The adult male was transported to WGH with undetermined injuries.

July 14

Police received a request to conduct a well-being check on an adult female in the South end of the City. Family reported having not heard from or being able to contact the adult female for some time. Police responded and discovered the female to be in the process of moving. All was well.

Police responded to a domestic dispute in the South end of City. An adult male and adult female were having a verbal altercation. Police assisted in calming the situation and no charges were laid.

July 15

Police received a complaint a sexual assault involving a female under the age of 18 and an adult male. The matter was investigated and the male was charged with one count of sexual assault, two counts of sexual interference and one count of failing to comply with the conditions of an undertaking. The adult male was released from custody with a pending court date.

Police received a complaint of fraud. An adult female has lost \$2600.00 after falling victim to a scam. The matter is under investigation.

Police responded to a complaint of a fight in a public place in the east end of the City. Witnesses reported two males fighting. Police attended and found two adult males having an altercation. The males were known to each other and the matter resolved peacefully. No charges were laid.

July 17

The Weyburn PS received a report of a possible Break & Enter to the office at River Park. Although entry was not gained there was some damage to a window. Anyone having information about this is asked to contact the Weyburn Police Service, or to call Crime Stoppers at 1-800-222-8477

July 18

At about 5:30 pm the Weyburn PS received a report of a possible impaired driver. Although the police in Weyburn were not able to locate this vehicle it was later reported driving dangerously on Hwy # 39 and evaded the RCMP in Estevan before the driver crashed the vehicle. A local Estevan man was taken into custody by the Estevan Police Service and is facing a number of charges including; Impaired Driving, Dangerous Driving and Evading Police. **We thank all those who were concerned enough to report this type of driving activity. Too easily this could have turned into a tragic situation with innocent people losing their lives.**

At about 11:20 pm the Weyburn PS received a complaint regarding eggs being thrown at a vehicle. A short time later another complaint was received about the same activity. As a result of the investigation two 17 year old male youth were identified as responsible and were issued tickets for throwing an object at a vehicle.

July 19

The Weyburn PS received a report of a bicycle stolen from an address on 8th Avenue SE. The bike is described as; Black Eastern and Nitrous XSIV bike with bright yellow grips and yellow brake cable. July 20

The Weyburn PS received a report of Mischief having been done to a vehicle where the rear window wiper was bent and the motor damaged.

The Weyburn Police have once again received a number of phone and internet scam reports this week. The most common this week seem to be receiving a phone call and being threatened by being arrested unless some payment was made.

July 21

The Weyburn PS received a report regarding an individual that was violating his Probation conditions. As a result of the investigation the 26 year old male was located and has been charged with Violation conditions on his Probation Order.

The Weyburn PS received calls regarding 2 male youth who were no longer welcome at the rodeo grounds due to their behavior. The youth were located and left without incident and were banned from future attendance during the weekend.

July 22

The Weyburn PS received a report that a counterfeit \$20 bill had been passed at the Weyburn Rodeo. At this time we do not have any information of who may have had the bill in their possession or where it originated. We urge all merchants and citizens alike to take an extra moment to assess the authenticity of any \$20 bills you may receive.

July 23

The Weyburn PS received a report regarding 2 at-large dogs which killed a neighbourhood cat. This is truly an unfortunate incident for all involved and underscores the need to keep your animals secured at all times; both dogs and cats are governed by the Bylaw and cannot be running at large.

At about 7:35 pm the Weyburn PS received a report of a suspected impaired driver. Although unable to locate the vehicle inside the City limits the RCMP encountered the vehicle just outside of the city. As a result a 36 year old male is now facing charges of Driving While Over .08.

Weyburn Police Service attended several complaints of Noise bylaw violations resulting from residential parties. There is a noise bylaw in the City that carries heavy financial penalties and potentially a court appearance. WPS would like to remind everyone to keep their gatherings manageable and to be respectful of their neighbors.

Weyburn Police Service received numerous complaints reporting scams of various descriptions. The most common are the "Canada Revenue Agency coming to get you if you don't pay NOW" and "family member is in jail and you must post bail NOW" scams. WPS would like to remind everyone to be very careful when they find themselves approached either by phone or online. Scammers are very good at what they do and are sometimes not easy to detect. If something seems odd, it probably is. Residents are encouraged to contact WPS if they have any concerns about contact made.
