Media Release for July 30, 2017 – August 13, 2017

July 30

The Weyburn Police Service was advised of a motor vehicle vs bicycle accident on a residential street. The bicycle had run into the back of a car causing damage but had left the scene. Police were able to locate the bicyclist who agreed to pay for the damages. No charges were laid.

Weyburn Police Service members arrested two individuals who had outstanding arrest warrants from Moose Jaw for Breach of Undertaking. The 30 year old male was remanded in custody for court on August 1st, while the 19 year old female was released to appear in court at a later date.

Members of the Weyburn Police Service were called to a report of three males fighting at a local bar. Police attended and found the individuals walking away from the parking lot. The individuals were spoken to and to ensure their safety they were given rides home. No charges were laid.

July 31

While on patrol a member of the Weyburn Police Service observed a male breaching his release conditions. The 24 year old male was arrested and charged with breach of an undertaking and was held overnight for court on August 1st.

August 1

The Weyburn Police Service received a call of a possible impaired driver approaching the City. Police located and stopped the vehicle a short time later. The driver, a 33 year old male, had been drinking and blew a warning, but was not charged criminally. It was also determined he was driving while suspended and was charged accordingly. His passenger, a 28 year old male, was found with open liquor, and was also issued a ticket.

Weyburn Police members arrested a 55 year old male for being intoxicated in public. The individual was also charged with breaching a probation order. He was later released from custody when sober and will appear in court at a later date.

Police attended to a report of a Break and Enter to the Beaver's Merchandise Shack in Tom Laing Park. The break and enter appears to have occurred between July 30th and August 1st and numerous clothing items were reported stolen. No suspects have been identified at this time and the investigation is ongoing.

August 2

While on patrol, Weyburn Police members conducted a traffic stop and found the driver, a 30 year old female, to have been driving while impaired. The accused was arrested and transported to cells, where she was charged with drive while impaired and over .08. She was later released from custody and will attend court later this month.

August 4

Police received a report of Graffiti on a building in the 100 Block of 3rd Street SE. Police patrolled the area and the subsequent investigation identified fifteen (15) separate addresses where, during the evening, suspect(s) had spray painted buildings or fences. No suspects have been identified, and the incidents remain under investigation

August 5

Police were called to a local bar for reports of a fight. Upon arrival police located one individual who was suffering from minor injuries from an assault. The matter remains under investigation.

August 6

Police were called to a local Car Dealership after a vehicle was found to have the windshield smashed. The incident remains under investigation.

Police were dispatched to an assault in progress at the corner of Coteau and 18th Street. Police determined it was domestic related and the situation was mediated with no charges being laid.

August 8

At about 12:10 am the Weyburn PS Members were dispatched to a residence regarding a 28 year old male damaging property. As a result a 28 year old male was taken into custody without incident. He is now facing a charge of Assault and a charge of Mischief. Alcohol was a contributing factor.

At about 11pm the Weyburn PS received a call regarding a female in distress. Upon patrolling the area they found a 17 year old male & female having a verbal disagreement. The matter was mediated.

August 10

The Weyburn PS was contacted to keep the peace while a tenant was evicted.

The Weyburn PS is investigating a number of historical sexual assaults. These matters are still under investigation and review to determine if the suspect was 12 years old or older at the times of the alleged offences.

In a matter loosely related to the above incidents the Weyburn PS has charged a 46 year old male with one charge of Sexual Assault from a dated occurrence. The accused will be making a Court appearance in the future.

August 12

The Weyburn PS was dispatched to a report of a single vehicle collision with private property. As a result of the investigation a 34 year old female has been charged with Driving with Undue Care & Attention.

The Weyburn PS received a report of a large dog attacking a smaller dog while both animals were being walked. We wish to remind dog owners that they are responsible for controlling their animals when out in public and can face both Bylaw and Criminal Charges should the circumstances dictate if another animal or person becomes injured. The smaller dog was treated at the Vet's.

August 13

The Weyburn PS is investigating a report of a Break & Enter to the washrooms in Jubilee Park.
