Media Release for October 8, 2017 – October 29, 2017

October 8

Weyburn Police Service was called to 3rd Street SE and 6th Avenue regarding an intoxicated individual, a 29 year old female was arrested and then shortly released into the care of a friend. No charges were laid.

October 9

Members of the Weyburn Police Service were called to twice to the same residence regarding a noisy party. The person in charge of the dwelling was warned during the first call. Shortly after, police were called again regarding ongoing noise. Police attended and after those in attendance had left, the person in charge of the residence, a 17 year old male was charged under the noise bylaw.

October 10

Police were called in regard to a domestic involving a mother and daughter. Upon arrival it was determined one of the parties had left the home. Police determined all involved were safe.

October 12

Police received a report of found property, which was later determined to have been stolen overnight from a vehicle that had been parked. Also stolen was a small amount of cash. Members of the public are reminded to lock their vehicles and to remove any valuables when leaving their vehicles unattended.

Members of the Weyburn Police Service conducted a curfew check at a local residence. As a result of the investigation, a 24 year old male, was charged with Breach of Recognizance and was issued a Summons for court at a later date.

October 13

Police received a report of an Assault after the victim, ayear old female attended the Weyburn Police Service and advised officers she had been grabbed and pushed into a wall. The investigation resulted in a 26 year old male being arrested and charged with Assault. He was released from custody and will appear in court at a later date.

Police were called to a residence regarding an intoxicated male. The individual was located and police assisted in getting the individual to their own residence. No charges were laid

Police received a call regarding a disturbance. Members of the Weyburn Police Service located a male and female arguing on the street. The matter was mediated and the parties left in opposite directions, no charges were laid.

October 14

The Weyburn Police Service received a call of a fight in progress on the street. Upon arrival police found two males walking in opposite directions. The investigation determined a short altercation had occurred between the two males. Both individuals were warned and sent home.

October 15

Members of the Weyburn Police Service conducted a vehicle stop and determined the passenger of the vehicle was on conditions from BC. The accused, a 24 year old male, was arrested. He was charged with Breach of Recognizance and later released for court at a later date.

The Weyburn Police Service was called regarding an intoxicated individual at a local residence. The individual, a 20 year old male, was turned over to family members to ensure their safety. No charges were laid.

The Weyburn Police Service received a call regarding a male walking down the street with a dog and who was kicking and yanking at the leash. Police located the male and dog and as a result of the investigation, the 28 year old male was charged with cruelty to animals and released for court at a later date. The dog was not injured and turned over to a responsible adult for its safety.

The Weyburn Police Service received a complaint of a fraud after the complainant who was trying to sell a vehicle on Kijiji was contacted by a potential buyer. The buyer had negotiated a price above the asking price but wanted some money wired from the seller before they would pay the premium price. The complainant did not send any money. As a reminder, please do not send any money or personal information to anyone that you do not know or as in this case where the deal appears to good to be true.

October 16

At about 12:25 pm the Weyburn PS was dispatched to a 2-vehicle collision at the Hwy # 39 and Queen Street Intersection. Upon investigation it was determined that a vehicle travelling South on Queen Street left the Stop Sign before safe resulting in a collision with a vehicle on Hwy # 39. A 44 year old female was issued a ticket for Leaving the Stop Sign before Safe to Do so. There were no injuries.

At about 12:15 pm the Weyburn PS received a call regarding a Hit & Run vehicle vs Bicycle collision on 2nd Avenue NW near King Street. The investigation determined that an 18 year old male was riding his bicycle across the crosswalk when struck by a vehicle described as:

- Black newer model pickup truck, grey chrome push bar, ball hitch on the bumper, large decal in the rear window. Anyone having information about this incident, or can identify the vehicle, is asked to contact the Weyburn Police Service at 306-848-3250 or to call Crime Stoppers at 1-800-222-8477.

The Weyburn PS received a report of a theft of merchandise from a downtown business. Upon review of the security footage a 37 year old male and 37 year old female were identified and have each since been charged with Theft Under \$ 5000 and will be making a Court appearance.

October 17

Weyburn PS received a report of that the previous evening someone ringing a doorbell then running away. The investigation identified a 16 year old male youth and 4 other youth were involved. The youth was dealt with through informal mediation. In the proper circumstances this simple childish act could amount to a criminal charge of Mischief and/or Trespassing on private property.

October 18

The Weyburn PS received a call from a downtown business owner who had apprehended a shoplifter in progress. As a result of the investigation a 32 year old male has been charged with Theft Under \$ 5000 and will be making a Court appearance.

October 20

At about 8:15 pm a Member of the Weyburn PS CTSS Unit conducted a traffic stop on a vehicle found to be driving without headlights. As a result of the stop a 29 year old female driver was arrested for Driving Over .08 and has been charged accordingly. The vehicle was impounded and the accused was issued an indefinite licence suspension.

October 22

At about 12:40 am while on patrol, a Member of the Weyburn PS CTSS Unit conducted a traffic stop on a vehicle driving at a fast rate of speed. As a result of the stop a 26 year old male driver was arrested and has been charged with Driving Over .08. The vehicle was impounded and the driver was issued an indefinite licence suspension.

October 23

The Weyburn PS received a complaint of a theft of credit cards from a residence. As a result of the investigation a 21 year old male has been charged with Being Unlawfully in a Dwelling House as well as numerous Credit Card Offences.

October 24

The Weyburn PS received a complaint regarding a domestic situation where threats had been uttered. As a result of the investigation a 17 year old female has been charged with Uttering Threats.

At about 11:05 pm the Weyburn PS was dispatched to a local bar regarding an unruly patron. As a result of the investigation a 36 year old female has been charged with Assault.

October 25

As a result of a vehicle stop an 18 year old male was found to be present in the vehicle and in violation of a curfew imposed by the Court. He is now facing a Breach of Undertaking charge.

The Weyburn PS received a complaint that a vehicle parked in the west central area of the City had the tires slashed. This would have happened during the night/early morning hours. October 26

The Weyburn PS received a report that about 3:25 pm an approximately 20 year old male in the area of the 200 Block of 3rd St N.E. was seen walking and carrying a large knife or sword. The Weyburn PS are seeking to identify this individual to determine that public safety is not an issue and no criminal action was present. October 28

At about 1pm the Weyburn PS received a report of what may best be characterized as a road rage incident. Upon investigation a 19 year old male has been charged with Assault With a Weapon. This appears to be an isolated incident and no one was injured in this case. This should simply serve to remind all motorists that while at times driving can be a frustrating task at no time should a driver consider taking the law into their own hands.

October 29

As the result of a vehicle check at 5:55 am the Weyburn PS conducted a roadside breath test on a 31 year old male driver. As a result the driver was issued a 72 hour vehicle suspension.
