Weyburn Police Service Media Release for January 15, 2018 - January 27, 2018

January 15

A vehicle previously reported as stolen from Weyburn was recovered in the Benson, Sask. area. The matter is concurrently under investigation by the Weyburn PS and the RCMP.

A 52 year old male has been charged with Breaching a Court-Ordered Condition and will be making a Court appearance in due course.

January 16

The Weyburn PS received a report of a scam that is new to our area. In this scam the caller receives a phone call from what is believed to be the Fraud Section of a particular Bank. The 'Bank' asks to deposit an amount of money into the account to test this and will send out a new bank card. Once again, this is a scam. If you have any questions regarding financial transactions or your personal information make sure you do not give out the information until you verify who you are speaking to and dealing with.

The Weyburn PS was called to a domestic dispute. The police were successfully able to mediate the matter with no need for further involvement.

January 17

The Weyburn PS assisted the Weyburn Fire Dep't at an industrial fire.

As the result of a traffic stop a 21 year old male driver was issued a Ticket for Drive while Suspended.

January 18

The Weyburn PS received a call to assist a young person who was having mental health issues. The person was assisted and obtained medical attention.

The Weyburn PS conducted a traffic stop which resulted in the 16 year old male driver being charged for Driving While Suspended. A traffic ticket was issued.

January 19

The Weyburn PS are investigating the theft of a stereo from a vehicle parked in the 100 Block of 6^{th} Street. Anyone having information regarding this matter is asked to contact the Weyburn Police, or to call Crime Stoppers at 1-800-222-8477

The Weyburn PS conducted a vehicle stop. A 14 year male was present in the vehicle and was known to have a Court-ordered curfew. As a result the youth was arrested for Breach of that Order and has been released for an upcoming Court appearance.

The Weyburn PS was called to a report of a domestic assault. The matter was mediated without the need for further police intervention.

January 20th

As a result of a compliance check on Court-ordered curfew conditions a 30 year old male was found to be in violation and has been charged with Breaching a Court Order. He will be making an upcoming Court appearance.

January 22

The Weyburn Police Service received report of a CRA fraud. The victim was contacted by an individual who threatened them to be arrested if they did not immediately pay back taxes. The victim was instructed on how to go about paying and eventually sent the caller money. Police are again warning everyone that CRA does not demand immediate payment and threaten arrest over the phone. If contacted by anyone you do not know who is asking for money to be sent please call your local authorities.

Police responded to a two vehicle motor vehicle accident at the intersection of Souris Avenue and Government Road. The investigation determined one of the vehicles had failed to stop for a red light, hitting the other vehicle in the intersection. EMS also attended and checked occupants of both vehicles, no injuries were reported. The driver, a 34 year old male, was charged with failing to stop for a red light.

January 23

The Weyburn Police Service received a report of an assault from a 31 year old female. The suspect a 33 year old female had approached the victim and a confrontation had occurred with the suspect pushing and yelling at the victim. The victim suffered no injuries. The investigation identified the suspect who was subsequently located and spoken to. No charges were laid in the incident.

January 24

Police received reports of two vehicles that had been parked in the NE area of Weyburn, near the same location, being entered overnight. Numerous items including a wallet, and cash were taken. The incidents remain under investigation.

Police investigated a reported mischief, after receiving information of graffiti being sprayed onto a sign and stature. Police identified a 69 year old male as a suspect. He was later located and warned of his actions. No charges were laid.

January 26

The Weyburn Police Service received a report of a mischief, after a vehicle was observed to be doing donuts in a parking lot. The dangerous driving resulted in gravel being flung through the local businesses windows. The incident remains under investigation.

The Weyburn Police Service received a report of a missing 20 year old male. Police later located the male who was then returned to his residence.

Police received a report of a vehicle which had been parked overnight being entered and numerous items being stolen. Some of these items were later located a short distance away and returned to the owner. The incident remains under investigation.

Police received a report of a parked vehicle being entered overnight and cash being stolen. The incident remains under investigation

Police were dispatched to a fight in progress at a local hotel. Upon arrival the individuals had left the scene but were located a short distance away. The individuals were not cooperative regarding the assault. A 35 year old female was found to have warrants for her arrest from Regina; she was remanded in custody to appear in court in Regina on January 29th.

A member of the Weyburn Police Service conducted a vehicle stop and during the course of the investigation found the driver to have a warrant for their arrest. The driver, a 48 year old male was arrested and later released to appear in court at a later date.

January 27

Police conducted a vehicle stop and determined the driver; a 62 year old male, was driving under the influence of alcohol. The driver was arrested and as a result of the investigation was charged with impaired drive, and drive while over .08. The accused was later released from custody and will appear in court at a later date.

As a result of an ongoing investigation, members of the Weyburn Police Service executed a Drug Search Warrant at a local residence. The search resulted in a 20 year old male being arrested and charged with possession of a quantity of drugs greater than 30 grams. The male was later released from custody and will appear in court at a later date.
